Preface

The Federal Emergency Management Agency directs¹ recipients of Homeland Security Grant Program or Emergency Management Performance Grant Program funding to have a current multi-year Integrated Preparedness Plan that identifies preparedness priorities and activities.

Though this plan is maintained by Vermont Emergency Management, this Integrated Preparedness Plan is the roadmap for how the Vermont whole community will close gaps in priorities described in the Stakeholder Preparedness Review.

Items noted in this Integrated Preparedness Plan use a cyclical approach: Once a plan, equipment or organization is developed or updated, then training is provided. The plan, equipment or organization is exercised, and the corrective actions and lessons learned are documented in the After-Action Review/Improvement Plan (AAR/IP). The plan, equipment, or organization is then updated based upon gaps identified in the exercise. Then the cycle begins again.

Vermont's training and exercise programs are administered by Vermont Emergency Management, in coordination with Federal Agencies, State Agencies, and local governments.

Background

This Integrated Preparedness Plan identifies the plans, organizational modifications, equipment, trainings, and exercises that will help the State build and sustain the Core Capabilities and close gaps identified during the Stakeholder Preparedness Review.

This plan includes proposed and scheduled activities for the years 2024-2027. It is representative of the natural progression that should take place in accordance with the HSEEP building-block approach.

Program Priorities

Program Priorities were identified during the 2023 Stakeholder Preparedness Review through the identification of high priority Core Capabilities. While these high priority Core Capabilities are the focus of this multi-year cycle of preparedness, items across all relevant core capabilities are included.

<u>Planning:</u> Conduct a systematic process engaging the whole community as appropriate in the development of executable strategic, operational, and/or tactical-level approaches to meet defined objectives.

<u>Public Information and Warning:</u> Deliver coordinated, prompt, reliable, and actionable information to the whole community through the use of clear, consistent, accessible, and culturally and linguistically appropriate methods to effectively relay information regarding any threat or hazard, as well as the actions being taken and the assistance being made available, as appropriate.

<u>Operational Coordination:</u> Establish and maintain a unified and coordinated operation structure and process that appropriately integrates all critical stakeholders and supports the execution of core capabilities.

<u>Physical Protective Measures:</u> Implement and maintain risk-informed countermeasures, and policies protecting people, borders, structures, materials, products, and systems associated with key operational activities and critical infrastructure sectors.

Cybersecurity: Protect (and if needed, restore) electronic communications systems, information, and services from damage, unauthorized use, and exploitation.

<u>Supply Chain Integrity and Security:</u> Strengthen the security and resilience of the supply chain.

Risk and Disaster Resilience Assessment: Assess risk and disaster resilience so that decision makers, responders, and community members can take informed action to reduce their entity's risk and increase their resilience.

<u>Infrastructure Systems</u>: Stabilize critical infrastructure functions, minimize health and safety threats, and efficiently restore and revitalize systems and services to support a viable, resilient community.

Long-Term Vulnerability Reduction: Build and sustain resilient systems, communities, and critical infrastructure and key resources lifelines so as to reduce their vulnerability to natural, technological, and human-caused threats and hazards by lessening the likelihood, severity, and duration of the adverse consequences.

<u>Intelligence and Information Sharing</u>: Provide timely, accurate, and actionable information resulting from the planning, direction, collection, exploitation, processing, analysis, production, dissemination, evaluation, and feedback of available information concerning physical and cyber threats to the United States, its people, property, or interests; the development, proliferation, or use of WMDs; or any other matter bearing on U.S. national or homeland security by local, state, tribal, territorial, federal, and other stakeholders. Information sharing is the ability to exchange intelligence, information, data, or knowledge among government or private sector entities, as appropriate.

Documentation

Training Documentation

Vermont Emergency Management tracks training completions via the Learning Management System (LMS)². Trainings offered through Vermont Emergency Management are entered into the LMS by the State Training Administrator and upon completion, are granted certificates or credits. Trainings sponsored by Vermont Emergency Management, such as FEMA or National Training Center Courses, are uploaded into the LMS for tracking purposes and students may also upload outside trainings to their transcripts.

All trainings within the LMS, including those that are completed, cancelled or in progress, are trackable and reportable. A variety of reports are generated for use in grant reporting and tracking progress of trainings identified in this Integrated Preparedness Plan.

Exercise Documentation

Exercises directed by Vermont Emergency Management staff are tracked using an Exercise Tracker, which captures information from the Concept & Objectives meeting to the After Action Meeting.

State Emergency Operations Center Improvement items are tracked using an internal tracker. Vermont Emergency Management and exercise personnel update improvements as they are completed.

Vermont requires that all local, regional, and state exercises funded through the State Homeland Security Grant Program or Emergency Management Performance Grant be designed, conducted and evaluated in accordance with the Homeland Security Exercise and Evaluation Program (HSEEP). HSEEP is the national standard for exercise implementation and evaluation, and as such, Vermont has adopted HSEEP as the standard. At the conclusion of each exercise, the final After Action Report/Improvement Plan is submitted to FEMA.

Plan Maintenance

In order to provide an effective Emergency Management program, Vermont will fully update this Integrated Preparedness Plan annually through hosting Integrated Preparedness Planning Workshop(s) and:

- Coordinating the Threat and Hazard Identification and Risk Assessment every 3 years.
- Coordinating the development of the Stakeholder Preparedness Review every year.
- Soliciting information from local, regional and state partners through the VEM Engagement Survey every 1-3 years.
- Reviewing After Action Reports for exercises and real-world events.
- Reviewing federal documents such as the National Preparedness Report, Notice of Funding Opportunities, and Information Bulletins.
- Reviewing input from partners, State leadership and policy group officials.

On a quarterly basis, Vermont Emergency Management will incorporate minor updates to this plan and post it on the Vermont Emergency Management website. If individuals that participated in the development of this plan are aware of changes, they should notify the corresponding point of contact on page 1 for incorporation in these quarterly updates.
