To be eligible, a nominee must:

Have been a duly appointed Emergency Management Director for their town/city at some point between October 1, 2020 and September 1, 2021.

Be from a town/city with a current Local Emergency Management Plan on file with Vermont Emergency Management.

Be enrolled in the Vermont EMD Certification Program or completed trainings within the program.

Benefit Cost Analysis Training August 4th & 5th: FEMA Region I will be providing a virtual Benefit Cost Analysis (BCA) training for Vermont on Tuesday August 3rd and Wednesday August 4th from 8:30 am to 12:30 pm. The BCA is a method that determines the future risk reduction benefits of a hazard mitigation project and compares those benefits to its costs.

MGT-323 Instructor Developed Workshop

A course to help develop and refine the skills of emergency response instructors will be offered virtually in October.

MGT-323 serves to give instructors insight into adult education and enhance the instructional skills and styles of those who train adult students. The course focuses on best teaching and training practices, and it enhances understanding of instructor competencies. This course emphasizes the active, learner centered style of delivery and student experience.

Instructors of the course model how to facilitate classroom discussions and motivate and encourage participants using a variety of strategies. Participants in the course will reflect on their learning and have many opportunities for self-evaluation.

The goal of this course is to ensure instructional excellence by providing a forum for experienced trainers to share their experiences with participants and learn together, both during discussions of instructional techniques and in commenting on each other's presentation skills during prepared teach backs.

This course will be held on October 4th-8th 2021 from 12:30 p.m. – 4:30 p.m. each day. It will be delivered virtually via Zoom Meeting Platform.
