# FY22 TVTP Grant NOFO Fact Sheet

#### Overview

This fact sheet provides information on the Targeted Violence and Terrorism Prevention (TVTP) Grant application process and requirements. This includes information on the application tracks and program types, required application materials, and key dates.

#### **Program Priorities**

The FY22 TVTP Grant Program provides funding to implement prevention capabilities in local communities and online, using both promising practices and innovative approaches. The Center for Prevention Programs and Partnerships runs the TVTP Grant Program as one of the ways it supports local communities in developing whole-of-society approaches to reducing targeted violence. Specifically, the TVTP Grant Program funds eight project types that help prevent or intervene with individuals radicalizing to violence and provides applicants with a separate Innovation Track to propose innovative solutions.

After assessing gaps in the applications and awards in previous cycles, CP3 has established the following priorities for award selection:

Enhancing Local Threat Assessment and Management Capabilities

The TVTP Grant Program provides funding to applications that align with these priorities and that protect privacy, civil rights, and civil liberties. Applicants are required to conduct a rigorous needs assessment to outline what resources are already available in their area and what gaps need to be filled. All projects have required performance measures.

# **Eligible Organizations**

State, local, tribal, territorial governments; non-profits; and institutions of higher education are eligible to apply for funds to establish prevention capabilities or fill gaps in their prevention capabilities. Applicants must be U.S.-based and implementing a U.S. based program.

#### **Cost Share or Match**

A Cost Share or Cost Match is not required.

# Period of Performance

The TVTP Grant Program has a period of performance of 24 months, with limited availability for nocost extensions.

### Other Eligibility Criteria

In addition to being an eligible organization, the proposed project must meet the following program eligibility criteria to apply:

- **Privacy, Civil Rights, and Civil Liberties:** All applications must appropriately protect privacy, civil rights, or civil liberties to be eligible.
- Completeness: All applicants must include all required elements (See Appendix C of the NOFO upon release, "Contents and Format of Application"), as well as the specific requirements of the project type(s) which they are proposing, which include performance measures (See Appendix B of the NOFO upon release). Failure to provide a complete application or significant deviation from the requirements can cause an application to be ineligible and not reviewed or scored.
- Research: Projects that only consist of research are not eligible under this program. To be eligible
  for an award, the applicant must propose the implementation of a prevention capability during the
  period of performance in addition to any research conducted under the award.

### Application Tracks and Funding

Under this opportunity there is a total of \$20,000,000.00 available for awards. Applicants can apply for one or more project types in the Promising Practices Track or submit a proposal in the Innovation Track. The following funding ranges are intended as benchmarks. If the project differs significantly from the funding target, the applicant should provide a detailed justification.

If applying to the Promising Practices Track, applicants should separate costs by project type in case partial funding is available. Please ensure that your application adheres to the requirements and other guidance provided in each track/project description.

### **Program Objectives**

The TVTP Grant Program develops local prevention frameworks that have the following objectives.

- Raising awareness of all aspects of why and how individuals radicalize to violence;
- Ensuring members of the local community are equipped and empowered to engage the broadest set of local stakeholders:
- Ensuring members of the local community have access to multi-disciplinary threat assessment and management teams;
- Ensuring members of the local community have the ability to act on their awareness training by knowing how to contact and understanding the role of threat assessment and management teams; and
- Ensuring the local community has programs that address risk factors while also providing services supporting threat management approaches.
