FY22 TVTP Grant Scoring Fact Sheet

Overview

This fact sheet provides information on the Targeted Violence and Terrorism Prevention (TVTP) Grant scoring process and requirements.

Needs Assessment: 15 Points

Applicants must describe the current <u>local prevention framework</u> or activities in the relevant localities that may become part of a local prevention framework as a result of the applicants' proposed project. Applicants should also demonstrate how the proposed project(s) move their locality/target population from the current state to their goal state.

Requirement	Points
The target population for services (the group of individuals that the proposed program	10
will serve) and the estimated number of people in that target population. The target	Points
population is not a simple demographic breakdown of your target location. The target	
population are the groups who will be directly impacted by project activities. The	
communities, age groups, and organizations/institutions of these groups should be	
specified.	
An inventory of other programs that currently serve the target population and	5 points
identification of gaps in these services that the proposed program will fill.	

Program Design and Implementation and Measurement Plan (IMP): 45 points

The program design is a critical part of the application that demonstrates the degree to which applicants understand how their proposed work will have an impact in preventing targeted violence and terrorism.

Project Narrative: All elements of the Program Design will demonstrate a clear	15
connection between the problem statement, program goals and objectives, and logic	Points
model/theory of change. Additionally, program design will be in line with the SMART	
model.	
Within IMP: Demonstrate clear understanding of performance measurement. This	15
includes quantifiable, time bound outputs, data collection methods, and adequate	points
methods for assessing the impact of activities. Performance measurements outlined in	
the IMP must follow requirements identified for each project type in Appendix B of the	
NOFO.	
Project narrative clearly identifies which grant program objectives the proposed project	10
intends to address and clearly outlines how applicant will achieve the associated	Points
outcomes.	
Project narrative and IMP clearly identify the project track and Types the proposed	5
project intends to address. Applicants also clearly justify why the selected project track	Points
and types are appropriate for the intended outcomes.

Organization(s) and Key Personnel: 15 Points

Applicants are required to describe their organization(s) and all key personnel (including contractors) that will work on the funded project(s).

Sustainability: 15 Points

Applicants are required to describe how the activities and capabilities in their proposed project will be sustained following the end of the period of performance.

Budget Detail and Narrative: 10 Points

Applicants are required to describe their budget in narrative form and provide a detailed budget breakdown with the associated cost categories.

Selection Process:

Each application will be reviewed by two subject matter experts who will consult, assign a consensus score to each scoring criterion, and provide notes regarding their decision. A selection panel will review the application scores, notes, and the following **selection criteria** to develop a funding recommendation:

- · Meeting the program priorities;
 - Implementing Prevention Capabilities in Small and Mid-Sized Communities
 - 2. Advancing Equity in Awards and Engaging Underserved Communities in Prevention
 - 3. Addressing Online Aspects of Terrorism and Targeted Violence
 - 4. Preventing Domestic Violent Extremism
 - 5. Enhancing Local Threat Assessment and Management Capabilities
- · Meeting the program objectives;
- Achieving diversity in project type while avoiding duplication of effort;
- Achieving geographic diversity (to include regions as well as type, e.g., urban, suburban, rural);
- · Achieving diversity in eligible applicant type; and
- · Maximizing the use of funds.
