VEM Day of Learning May 26, 2022—Call for Speakers

Vermont's Day of Learning will take place on May 26, 2022 at Lake Morey Resort in Fairlee. This event is an in-person (with a remote option) learning opportunity for emergency responders, town officials, and other partners in emergency preparedness, response, and recovery.

The Call for Speakers for the Day of Learning is now open, those who were selected as speakers for the original date in January need to re-submit their proposal. Sessions are 45 minutes long and those who are interested in presenting should submit their proposals before noon on Friday, March 25th.

FEMA Seeks New Members for National Advisory Council

FEMA is seeking qualified individuals to lend their expertise and serve on the agency's National Advisory Council.

The National Advisory Council includes a geographically diverse and substantive cross-section of 35 members who advise the FEMA Administrator on all aspects of emergency management, ensuring input from and coordination with state, local, tribal and territorial governments, as well as the private and nonprofit sectors.

Individuals appointed to the council bring their experience and diversity of views to provide the Administrator consensus recommendations on a broad range of issues.

Selected council members will guide future recommendations on topics including equity, climate, readiness, and workforce. The agency is accepting applications for 14 positions.

This recruitment announcement includes solicitation of a climate expert. Newly selected members will serve up to a three-year term on the council. If other positions open during the application and selection period, FEMA may select qualified candidates from the pool of applications.

Procedural Masks Available for Vermont Municipalities

The Vermont State Emergency Operations Center is once again distributing masks to communities as part of a strategy of protecting essential services and vulnerable populations.

Procedural (sometimes called surgical) masks are available for cities and towns that request them. These masks can be used as needed. They can be placed in your town office for visitors and staff, given to local businesses, or distributed to vulnerable populations. These could also be used if your Town is planning any large gatherings, including Town Meeting Day.

VEM has already reached out directly to community Emergency Management Directors

with an offer of masks equal 45% of their town's population. 136 towns have accepted the offer and masks will be distributed throughout February.

These mask will be distributed on a first come first serve basis.

Vermont Spring Flood Sessions Available On-Line

Vermont Emergency Management and its partners hosted the annual Spring Flood Seminars in late January and early February.

These events featured presentations on the latest forecast for spring flooding and ice jams, and where to get assistance to prepare, respond, and recover from flooding. Topics included emergency response assistance available from state and federal agencies, emergency planning, disaster recovery, hazard mitigation opportunities, and other topics.
