Spring Flood Seminars

Winter is only weeks old, but it's not too early to start thinking about spring flooding.

Vermont Emergency Management and its partners will host Vermont's annual Spring Flood Seminars starting in late January. These events are an opportunity for emergency managers and community leaders to hear the latest forecast for spring flooding and ice jams, and where to get assistance to prepare, respond, and recover from flooding. Topics include emergency response assistance available from state and federal agencies, emergency planning, disaster recovery, hazard mitigation opportunities, and other topics.

All are welcome to attend the Spring Flood Seminars, and community leaders who may be involved in disaster response or recovery are encouraged to take part. These virtual Spring Flood Seminars will be held live through Microsoft Teams on:

Each Spring Flood Seminar will feature:

- National Weather Service: Will provide a spring flood outlook and inform decision makers about flooding causes and potential mitigation efforts.
- Vermont Emergency Management: Will discuss planning, training, and exercise services available in your community. Recovery & Mitigation Section staff will discuss their interface with FEMA to deliver federal disaster recovery and mitigation programs to Vermont Communities.
- Agency of Transportation: Overview of resource connections and overall technical advice.
- Agency of Natural Resources: Who to call and what permits are needed when working in streams or floodplains.
- Agency of Human Services
- VT National Guard
- Division of Fire Safety
- Regional Planning Commissions

Deadline Approaching for Round 2 of Flood Resilient Communities Fund Grants

The next round of funding under the Flood Resilient Communities Fund (FRCF) is fast approaching: deadline is Monday, January 31, 2021.

We have an additional \$2 million available for Round 2 in January. If you have any project ideas you would like to discuss, please reach out to Vermont Emergency Management at 802-989-6793 or stephanie.a.smith@vermont.gov

\$2.6 million was awarded in round 1 to towns, state agencies, and non-profits in Vermont to reduce the future public safety and water quality impacts of climate-related flood hazards. The projects funded under the Flood Resilient Community Fund program will improve the landscape, enhance community resilience to flooding, and improve water quality in Vermont.

The Flood Resilient Community Fund was established in the spring by the Vermont

legislature. The \$4,880,000 program is funded by the American Rescue Plan Act (ARPA).

Two Rivers-Ottauquechee Regional Commission – floodplain restoration project

Friends of the Mad River – planning, scoping, outreach on development of priority projects

Town of Cabot – riparian tree plantings for culvert project.
