## VEM Director Erica Bornemann Elected President of National Emergency Management Association

Vermont Emergency
Management Director Erica
Bornemann has been
selected as the President of
the National Emergency
Management Association
(NEMA). Bornemann was
previously voted in as VicePresident by Emergency
Management Directors
representing all U.S. states

and territories. The NEMA Vice-President is annually elevated to the Presidency of the organization.

"I am so honored to have been elected by my colleagues nationwide to lead NEMA over the coming year," said Bornemann. "While my primary focus will remain addressing the current and future challenges in Vermont, I look forward to working with the dedicated public servants in NEMA to continue to improve disaster outcomes in an equitable, efficient, and transformative way."

NEMA is a nonpartisan, nonprofit association dedicated to enhancing public safety in all 50 states, eight U.S. territories, and the District of Columbia. NEMA provides national leadership and expertise in comprehensive emergency management; serves as a vital emergency management information and assistance resource; and advances continuous improvement in emergency management through strategic partnerships, innovative programs, and collaborative policy positions.



Bornemann succeeds outgoing President Sima Merick of Ohio, the two were the first women to serve simultaneously as President and Vice-President of NEMA.

Erica Bornemann has been Vermont Emergency Management Director since

January of 2017 and has worked for VEM since 2007. Erica previously served as Chief of Staff, and as Planning Chief for the Division, during which time she oversaw the Radiological Emergency Response Program as well as the State Emergency Operations Plan. Erica holds a Bachelor of Arts in Political Science from Western New England College and a Master of Public Administration from Norwich University. She lives in Hyde Park with her husband and two sons.

## Hazard Mitigation Planning Workshop—November 18

Vermont Emergency Management VEM will be providing a virtual workshop on developing Local Hazard Mitigation Plans (LHMPs) on Thursday November 18th from 9:00am to 12:00pm. After a break for lunch, participants are invited back to ask questions about specific plans in need of technical assistance until 2:30pm.

This workshop is geared towards planners who develop LHMPs for municipalities in Vermont. Municipal staff who will be part of a plan update or development process are also welcome.

There will be a review of local hazard mitigation planning requirements and discussion around ideas for improving the effectiveness of plans for Vermont communities. If you attended the FEMA training it will be an opportunity to ask specific follow up questions to better understand applicability of guidance in Vermont.

## **Building Resilient Communities Grants**

Vermont has \$1 million available for Building Resilient Infrastructure and Communities (BRIC) grants in 2021. Among eligible projects is funding for Project Scoping.

This funding the can be utilized to study a particular problem, develop an analysis of alternatives, develop designs and a budget for the preferred alternative, and develop a Benefit-Cost Analysis for a future hazard mitigation grant application.

If you have communities with a specific flood concern, like an undersized bridge, or a potential area for floodplain restoration or dam removal to reduce downstream flooding, this is a great opportunity to assess options and develop a solution for future funding.

Applications are through FEMA Go with a State deadline of December 17, 2021. RPCs and municipalities are eligible applicants.

If you have a project in mind, reach out soon to discuss developing an application. Please also share this opportunity with your communities.

## **Homeland Security Funds Available**

The 2019 Reallocation State Homeland Security Grant Program (SHSP) Request for Proposals (RFP's) is now open. Applications are due by 5:00 pm, November 26th

The SHSP is intended to prevent terrorism and other catastrophic events, and to prepare the Nation for the threats and hazards that pose the greatest risk to the security of the United States. Ideally, funding should support deployable assets that can be used anywhere in the Nation through automatic assistance and mutual aid agreements, including, but not limited to, the Emergency Management Assistance Compact (EMAC).

The HSGP funding supports investments that improve the ability of jurisdictions nationwide to:

- Prevent a threatened or an actual act of terrorism.
- Prepare for all hazards and threats,
- Protect citizens, residents, visitors, and assets against the greatest threats and hazards, relating to acts of terrorism, and/or
- Respond quickly to save lives, protect property and the environment, and meet basic human needs in the aftermath of an act of terrorism or other catastrophic incidents.

#### **ELIGIBLE EXPENSES**

1. SCREENING, SEARCH, AND DETECTION, INTERDICTION AND DISRUPTION, AND/OR INTELLIGENCE AND INFORMATION EQUIPMENT

State and local law enforcement agencies may apply for funds to purchase Screening, Search, and Detection and/or Interdiction and Disruption equipment. The objective of these funds is to reduce gaps and increase percentages of target(s) achieved within the Stakeholder Preparedness Review and Core Capabilities.

2. MASS SEARCH AND RESCUE EQUIPMENT AND SUPPLIES

State and local agencies with the responsibility of supporting or carrying out Mass Search and Rescue Operations may apply for funds for search and rescue equipment and associated supplies, Personal Protective Equipment (PPE), and Utility Vehicles (UTVs). The objective of these funds is to reduce gaps and increase percentages of target(s) achieved within the Stakeholder Preparedness Review and Core Capabilities.

#### 3. INTEROPERABLE COMMUNICATIONS

State and local agencies may apply for funds to support interoperable communications projects. The objective of these funds is to reduce gaps and increase percentages of target(s) achieved within the Stakeholder Preparedness Review and Core Capabilities. Regional communications projects will be prioritized.
