



**Sept. 11, 2001:** Terrorists attack the United states

**Sept. 18, 2001:** The first letters containing anthrax are mailed.

**Oct. 4, 2001:** Bob Stevens of American Media in Florida is hospitalized with inhalation anthrax

Oct. 5, 2001: Stevens, 63, dies. It's the first anthrax death in the U.S. in 25 years.

Oct. 15, 2001: Senate Majority Leader Tom Daschle (D-SD) tells reporters anthrax was found in his office

Oct. 23, 2001: Two postal workers from the Brentwood facility in Washington, D.C., are confirmed to have died from inhalation anthrax.

Oct. 5, 2001: Stevens, 63, dies. It's the first anthrax death in the U.S. in 25 years.

**Oct. 31, 2001:** Kathy Nguyen dies from inhalation anthrax.

**Nov. 21, 2001:** Ottilie Lundgren, 94, of Connecticut, becomes the fifth person to die from inhalation anthrax.

Dec. 2003: The Brentwood postal facility reopens in Washington, D.C., after more than \$130 million worth of renovation and cleanup..

THE ANTHRAX THREAT

Loner Likely Sent Anthrax, FBI Says



WASHINGTON -- The FBI is increasingly convinced that the person behind the recent anthrax attacks is a lone wolf within the United States who has no links to terrorist groups but is an opportunist using the Sept. 11 hijackings to vent his rage, investigators said Friday.

Based on case studies, handwriting and linguistic analysis, forensic data and other evidence, authorities do not believe at this point in their five-week investigation that Osama bin Laden's Al Qaeda network was behind the anthrax attacks, FBI officials said.

Instead, FBI investigators said at a news briefing that they are probably looking for an adult male with at least limited scientific expertise who was able to use laboratory equipment easily obtained for as little as \$2,500 to produce high-quality anthrax. FBI officials, in offering their most expansive public assessment to date of their probe, are hoping that the rough profile they have developed of the anthrax culprit could produce a redux of their 1996 capture of the infamous Unabomber.

# 2018 Salisbury Poisonings

4 March 2018 – Sergei and Yulia Skripal found unresponsive on park bench.
Symptoms initially thought to be drug overdose turned out to be nerve agent poisoning.

5 March 2018 – Major Incident Declared. Detective Nick Bailey who visited Skripal's house hospitalized for exposure. Admitted to hospital in critical condition discharged 22 March 2018.

30 June 2018 – Two British nationals admitted to hospital for poisoning, Dawn Sturgess and Charley Rowley. Police determine that its same Novichok agent. Perfume bottle containing agent found to have enough agent to "kill thousands of people. Dawn dies from her exposure.

22 Nov 2018 – Detective Nick Bailey releases interview stating he was wearing a forensic suit and that lost his home and all possessions due to possible contamination.

### **SAFETY AWARENESS FOR FIRST ON-SCENE RESPONDERS\***


#### Introduction

- ▶ This information is part of ongoing preparedness for all hazards and is intended to help you protect yourself if an incident ever occurs involving a fourth generation agent (FGA, also known as A-series or Novichok nerve agents), such as the one used in the United Kingdom in 2018. No illicit use or manufacture of an FGA or other nerve agent is known to have occurred in the United States, and there is no known threat of any nerve agent use in the United States.
- ▶ If an incident occurs involving an FGA, first on-scene responders (law enforcement, fire, and emergency medical services personnel) initially may be unaware that an FGA is present. Conduct an appropriate initial scene assessment in accordance with standard protocols. Implement protocols for a hazardous materials response if you suspect any potential nerve agent incident, and ensure the local FBI Weapons of Mass Destruction (WMD) Coordinator is notified immediately. The FBI will investigate the threat or presence of any nerve agent, including FGAs, as a violation of federal law.
- ▶ The National Guard WMD-Civil Support Teams (WMD-CSTs) possess unique training and have specialized U.S. government fielded equipment to perform field identification to assist local and state responders. Your state Emergency Operations Center can contact the WMD-CSTs if you suspect a nerve agent release.

#### WHAT IS OUR MISSION

  - 2. Assist with appropriate requests for state response.
  - 3. Advise on appropriate response measures
  - 4. Identify CBRN agents / substances

- Responds under authority of Governor, may respond as part of Federal mission, <u>always within the homeland.</u>











# 2020 COVID Sample Mission
