  - a. Todd Cosgrove reported on Tier II submissions CSV file ability has been added for next year's Tier II software.
  - b. Todd Cosgrove reported on the HAZMAT Team
    Repurposed Stowe response trailer, enabling response to any large spill in the state.
    Goal is to get another one for the southern portion of the state.
  - c. Tim Cropley presented ANR Spill Team Calls Report for previous quarter
- 7. Re-Alignment of LEPCs Discussion (All)
  - a. Erik Rosenbauer LEPC/SERC Liaison Committee Report Invitation to join this Committee was made to all present (chaired by an appointed SERC member). LEPC 9 sent their Response Plan to the SERC for review and it was very well done.
  - b. Challenging to find enough volunteers to cover all the existing LEPCs, whereas consolidating into just a few (possibly 1, 2 or 4 LEPCs) would enable them to have more volunteers, expertise, and funds. Discussed State funding for positions currently performed by volunteers. Could have temporary or contractual based employees to work specific projects. The SERC does not want to discourage current active LEPCs. The SERC would like to show appreciation to those LEPCs that have been actively participating and putting in many hours of volunteer time. LEPC 6 volunteered to fund the inaugural annually recurring LEPC Chair dinner/meeting with details to be determined. Suggestion to have this yearly to coincide with the VEM Emergency Preparedness Conference was also discussed. RPC staff that supports LEPCs should also be invited to this first LEPC Chair dinner. Location of the dinner will be the Vermont





Technical College in Randolph. Tory Littlefield will arrange booking this venue once a date has been finalized. The end state of this year's annual LEPC Chair Dinner will be to have a validated redistricting LEPC model for the SERC to ratify.

- c. The LEPC/SERC Liaison Committee will meet to frame the SERC recommendations for reconfiguring the LEPCs, will present the proposal to LEPCs and bring feedback back to the SERC for the next meeting in November.
