Committee Reports

Finance Subcommittee report – Department of Public Safety (DPS) Finance provided a brief update of where FY'18 funding stands on what reporting is still required from some specific LEPCs. Kim Lapierre (SERC Finance Subcommittee Chair) reported out on recent activity of the subcommittee. A workshop was hosted by this subcommittee on February 12, 2018 where LEPCs were educated on best practices for applying for FY'19 Hazchem funding.

A suggestion was made from a member of the public that the SERC Finance Subcommittee send out a letter to LEPCs by June/July to ask for their input into the FY'20 budget creation process for the Hazchem fund.

Update by Chief Peter Lynch on 2017 activity the Vermont Fire Academy conducted.

SERC/LEPC Subcommittee report - Prescott Nadeau reported out on the first meeting of the SERC/LEPC Liaison Subcommittee. The direction is that this subcommittee will provide guidance to the LEPCs on what reporting the SERC is looking for.

There was some discussion about holding future SERC meetings in different locations throughout the state. LEPC 2 – Rutland County was decided upon as the next location for May 16, 2018 SERC Regular Meeting. Exact meeting location will be warned at a later date.

SERC Chair Todd Cosgrove instructed SERC members to think about SERC Subcommittees that need to be formed to do various tasks, such as a by-law subcommittee or a subcommittee to create a process for how potential members of the SERC are selected and recommended to the Governor for appointment.
